Welcome + Introductions

Matt Horn, MRB Group, welcomed the Steering Committee attendees to the second Steering Committee meeting. Shaun Logue, MRB Group provided an overview of the Agenda and what will be discussed. Meeting minutes from the September 10, 2020, Kick-off meeting were approved.

Project Updates

Shaun began the meeting with updates to the process and project status:

Public Participation Plan (PPP): Copies of the PPP were provided to Committee members on September 21st and were asked to review the document and provide feedback. It was mentioned that the PPP would need to be revised from time-to-time. The PPP was approved by the Steering Committee.

Community Survey: The Committee received a draft copy on September 21st and were asked to review and provide input prior to the October 6th meeting. Comments were received and the Committee members provided additional input at the meeting. The revised Community Survey went live on the Onwardontariony.org website on October 9th.

Webiste: Shaun revealed the project website, Onwarontariony.org and walked the Committee members through the different elements and website pages. Shaun informed the group that the survey will have its own page. The website will be directly link to the Town of Ontario's homepage.

Community Activities: Shaun and Matt discussed setting the date, time and location for the first public workshop. After deliberation and going over Department of Health requirements, the Committee set the date for December 10th, 2020 from 6:00 – 9:00 p.m. at the Parks & Recreation Community Center at Casey Park. The Committee agreed that it will be an "Open House" format to meet the social distancing guidelines.

Additionally, the Committee recommended reaching out to the Superintendent of Wayne Central School District in an effort to sending information relating to the webpage, survey and the first public workshop. It was also discussed contacting the local Rotary Club, which meets every Tuesday of the month in an effort in spreading the word.
